I freely waive any and all rights to file a claim or commence litigation against any of the entities mentioned above with respect to any claim of negligence I may have that is in any way related to my participation in this event. B) I agree to indemnify and hold harmless the entities or persons mentioned in Section A above from any and all claims made by any other individual or entity relative to my participation in this event, or any injuries, losses or damages that result from it.

I hereby consent to receive medical treatment, which may be deemed advisable in the event of injury, accident and/or illness during this event. I am aware that this event is not an event permitted by USA Cycling and that USA Cycling insurance does not apply. I understand that at this event or related activities I may be photographed. I agree to allow my photo, video or film likeness to be used for any legitimate purpose by the event holders, promoters, sponsors, organizers and/or assigns. I hereby assume all of the risks of participating and/or volunteering in this event. I realize that there may be acts or omissions, negligence or carelessness on the part of the persons or entities being released. I realize that there may be dangerous or defective equipment or property owned, maintained or controlled by them. I certify that I am physically fit, have sufficiently trained for participation in this event and have not been advised otherwise by a qualified medical person.
